## PLASTIC OMNIUM SIGNS CONTRACT WITH EDF GROUP TO SUPPLY RENEWABLE ELECTRICITY COVERING HALF OF ITS NEEDS IN FRANCE

Plastic Omnium has signed a contract with EDF Renewables that will cover around 50% of its electricity needs with low-carbon electricity by 2025. The renewable electricity will be produced at five new photovoltaic power plants developed, built and operated in France by EDF Renewables and its Luxel subsidiary. This strategic choice sees Plastic Omnium reach a new milestone on its path to carbon neutrality in scopes 1 and 2 by 2025.

The 20-year power purchase agreement (PPA<sup>1</sup>) will see direct purchases of renewable electricity, including a total annual production capacity of 45 GWh of electricity<sup>2</sup>, enough power to meet the needs of a population of 20,000. The five photovoltaic power plants will provide power to Plastic Omnium's 14 sites in France.

Plastic Omnium has succeeded in delivering a 26% cut in CO<sub>2</sub> emissions from its in-house activities (Scope 1) and its energy use (Scope 2) since 2019. These efforts form part of its Top Planet program, first rolled out in 2006 with the goal of cutting the environmental impacts of production at its plants.

Laurent Favre, Chief Executive Officer of Plastic Omnium, says: "This new production capacity for low-carbon electricity will allow Plastic Omnium to significantly ramp up the share of renewables in its energy mix. The landmark contracts we are signing today with EDF Group mark a major milestone in delivering our ambitious carbon neutrality roadmap, while also locking in our long-term energy costs."

As energy supplier to Plastic Omnium, EDF Group has the in-depth knowledge of its activities and processes needed to help Plastic Omnium meet its decarbonization goals, which are setting the standard for energy transition in the automotive industry.

EDF Group and its subsidiaries cover the complete PPA value chain, with EDF Renewables developing, constructing, and operating photovoltaic power plants, and Agregio Solutions aggregating renewable electricity production and incorporating it into the power supplied to its customers.

(1) A power purchase agreement (PPA) is a long-term contract for the delivery of renewable electricity. The electricity can be produced by photovoltaic panels or wind turbines installed directly at Plastic Omnium sites, or at sites used exclusively for producing electricity.
